

## United Way of Danville Area, Inc. Incentive Program Rules

### 1) Eligibility

- a. The United Way of Danville Area, Inc. Incentive Program is open to all legal residents that live or work in Vermilion County, IL, Fountain County, IN and Warren County, IN, who are at least twenty-one (21) years of age at the time of the final drawing.
- b. Participates must pledge \$104.00 for the 2018/19 United Way Campaign, example \$2.00 a week, through payroll deduction with their employer and must be fulfilling the pledge at the time of the final drawing.
- c. Participates outside of the work place must pledge \$104.00 or more for the 2018/19 United Way Campaign and be paying as represented on their pledge form at the time of the final drawing.
- d. The \$104.00 that it takes to be in the program is **not** tax deductible. Any amount given over the \$104.00 is tax deductible as allowed by law. We are a non-profit with a 501©(3) status.
- e. Employees and Board of Directors of United Way of Danville Area, Inc. and Carmack Car Capitol Managers are not eligible to win. The program is subject to federal, state and local laws and regulations.

### 2) Sponsors

- a. The program is sponsored by United Way of Danville Area, Inc., located at 28 W. North Street, Suite 102, Danville, IL 61832.

### 3) Agreement of Official Rules

- a. Participation in the program constitutes donors full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding.
- b. Winning the incentive is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

### 4) Program Period

- a. This program begins on March 1, 2018 at 8:30a.m. CST and ends on February 1, 2019 at 4:30p.m. CST.
- b. Entries submitted after the program period ended will not be eligible during the 2018/2019 United Way Campaign.
- c. Submissions will be accepted via paper pledge or electronic pledge.

### 5) How to Enter

- a. Via paper or electronic pledge form completed individually or through an employer.
- b. Forms can be picked up at the United Way of Danville Area, Inc. office at 28 W North Street, Suite 102, Danville, IL 61832, through electronic submission at [www.unitedwayda.com](http://www.unitedwayda.com) or through your employer Human Resource Department.

- c. All pledge forms become the property of the Sponsor.
  - d. The United Way office will mail a verification letter to you once the pledge is received and entered. Please allow at least fifteen (15) business days for your confirmation to arrive. If said notice is returned without forwarding instructions no further attempt will be made to deliver the notice.
  - e. United Way of Danville Area, Inc. employees, Board of Directors or volunteers assume no liability for lost, late or undelivered pledges.
  - f. Checks or credit cards that are denied or returned for insufficient funds or other reasons makes the pledge and program entry void until cash or money order is received to cover said pledge.
- 6) Potential Program Winners
- a. Two (2) participant names will be selected each day into the program on December 3, 2018, January 2, 2019 and February 1, 2019 at 7:30a.m. CST.
  - b. The Sponsor will select potential winners in a random fashion from among all eligible pledges received.
  - c. The odds of being selected depend on the number of pledges received.
  - d. **Final winner must provide proof of auto insurance and a valid driver's license to Carmack Car Capitol should they choose a vehicle as their prize.**
- 7) Prize Presentation
- a. The final drawing from the six (6) potential winners will take place at Carmack Car Capitol at 3649 N. Vermilion Street, Danville, IL 61832 at a date TBD.
  - b. The Final Winner from the six (6) potential winners will have the choice of one (1) of the following: 2019 Hyundai Kona, 2019 Hyundai Sonata or \$20,000 Cash Prize before taxes.
  - c. United Way of Danville Area, Inc. is required by law to report such winnings to the Internal Revenue Service and to withhold appropriate taxes on cash winnings of \$5,000 or more.
